The Neumann Problem of Complex Special Lagrangian Equations with Supercritical Phase

Abstract. Inspired by the Neumann problem of real special Lagrangian equations with supercritical phase, we consider the Neumann problem of complex special Lagrangian equations with supercritical phase in this paper, and establish the global C^2 estimates and the existence theorem by the method of continuity.

Key Words: Special Lagrangian equation, Neumann problem, supercritical phase.

1 Introduction

As we all know, the real special Lagrangian equation is

$$\arctan D^2 u = \Theta(x),$$
 (1.1)

where

 $\arctan D^2 u := \arctan \lambda_1 + \arctan \lambda_2 + \dots + \arctan \lambda_n$

 $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n)$ are the eigenvalues of the Hessian matrix

$$D^2 u = \left\{ \frac{\partial^2 u}{\partial x_i \partial x_j} \right\}_{1 \le i, j \le n}$$

and Θ is called the phase. In particular, $\Theta = \frac{(n-2)\pi}{2}$ is the critical phase, and if $\frac{(n-2)\pi}{2} < \Theta(x) < \frac{n\pi}{2}$, Eq. (1.1) is called special Lagrangian equations with supercritical phase.

The special Lagrangian equation (1.1) was introduced by Harvey-Lawson [13] in the study of calibrated geometries. Here Θ is a constant called the phase angle. In this case the graph $x \mapsto (x, Du(x))$ defines a calibrated, minimal submanifold of \mathbb{R}^{2n} . Since the work of Harvey-Lawson, special Lagrangian manifolds have gained wide interest, due in large part to their fundamental role in the Strominger-Yau-Zaslow description of mirror symmetry [26].

For the special Lagrangian equations with supercritical phase, Yuan obtained the interior C^1 estimate with Warren in [29] and the interior C^2 estimate with Wang in [28]. Recently Collins-Picard-Wu [8] obtained the existence theorem of the Dirichlet problem.

Moreover, for the Dirichlet problem of elliptic equations in \mathbb{R}^n , many results are known. For example, the Dirichlet problem of Laplace equation is studied in [7, 11], Caffarelli-Nirenberg-Spruck [2] and Ivochkina [15] solved the Dirichlet problem of Monge-Ampère equation, and Caffarelli-Nirenberg-Spruck [4] solved the Dirichlet problem of *k*-Hessian equation. After the pioneering works of Caffarelli et al., the Dirichlet problem of the general Hessian quotient equation was solved by Trudinger in [27]. For more information about the related subjects, we refer to the citations of [2,4,15].

Also, the Neumann or oblique derivative problem of partial differential equations was widely studied. For a priori estimates and the existence theorem of Laplace equation with Neumann boundary condition, we refer to the book [11]. Also, we can see the recent book written by Lieberman [21] for the Neumann and the oblique derivative problems of linear and quasilinear elliptic equations. In 1986, Lions-Trudinger-Urbas solved the Neumann problem of Monge-Ampère equation in the celebrated paper [23]. Recently, Ma-Qiu [24] solved the the Neumann problem of *k*-Hessian equations, and Chen-Zhang [6] generalized the result to the the Neumann problem of Hessian quotient equations. For the Neumann problem of special Lagrangian equations with supercritical phase, Chen-Ma-Wei [5] got the existence theorem. In [16, 17], Jiang-Trudinger studied the general oblique boundary value problems for augmented Hessian equations with some regular condition and some concavity condition.

At the same time, the complex equations have attracted a variety of mathematicians and many excellent works have been done. The complex Monge-Ampère equations are definitely one of the most important equations in partial differential equation and the geometry. In [1], Bedford and Taylor studied the Dirichlet problem of complex Monge-Ampère equations by using the Perron-Bremermann family method, and got the existence and uniqueness of the weak solutions and a global Lipschitz regularity for plurisubharmonic solution when Ω is a bounded strictly pseudoconvex domain in \mathbb{C}^n . In [3], Caffarelli et al. studied the classical solution on strongly pseudoconvex domains. Their work was extended to arbitrary bounded domains in \mathbb{C}^n by Guan in [12] under some subsolution condition. Recently, Fu-Yau equation on compact Kähler manifolds arises much attention, which was introduced in [10]. The Fu-Yau equation was solved in dimension 2 by Fu-Yau and was recently extended to higher dimensions in some cases in [25] by Phong, Picard and Zhang. In high dimensions, the equation is actually a 2-Hessian type equation. Complex Hessian equations have been studied extensively by many authors in recent years. On \mathbb{C}^n , the Dirichlet problem of complex Hessian equation was studied by Li [20] under some strict subsolution condition. On compact manifolds there were the existence of admissible solution in [9, 14]. For the Neumann problem of complex Monge-Ampère, Li proved the existence under some other conditions in [19].

Naturally, we want to know how about the problem of complex special Lagrangian equations of the form

$$\begin{cases} \arctan \partial \bar{\partial} u = \Theta(z) & \text{in } \Omega, \\ D_{\nu} u = -\varepsilon u + \varphi(z) & \text{on } \partial \Omega, \end{cases}$$
(1.2)

where Ω is a strictly pseudo-convex domain in \mathbb{C}^n , $\varepsilon > 0$ is constant, ν is the outer unit normal vector of $\partial\Omega$, u is a C^2 and real valued function in Ω , Θ is a real valued function in Ω , $\partial \bar{\partial} u = \{\frac{\partial^2 u}{\partial z_i \partial \bar{z}_j}\}_{1 \le i,j \le n}$, and $\arctan \partial \bar{\partial} u :=: \arctan \lambda_1 + \arctan \lambda_2 + \dots + \arctan \lambda_n$, where $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n)$ are the eigenvalues of the complex Hessian matrix $\partial \bar{\partial} u$. In the following, we denote

$$z = (z_1, \dots, z_n) \in \overline{\Omega}, \quad z_j = t_j + \sqrt{-1} t_{n+j}, \quad t = (t_1, \dots, t_n, t_{n+1}, \dots, t_{2n}),$$

$$\partial_j u = \frac{\partial u}{\partial z_j} = u_{z_j}, \quad \partial_{\overline{j}} u = \frac{\partial u}{\partial z_{\overline{j}}} = u_{z_{\overline{j}}}, \quad \partial u = (\partial_1 u, \dots, \partial_n u),$$

$$D_k u = \frac{\partial u}{\partial t_k}, \quad Du = (D_1 u, \dots, D_{2n} u),$$

where $\sqrt{-1}$ is the imaginary unit. It is easy to know

$$\partial_{j}u = \frac{1}{2}[D_{j}u - \sqrt{-1}D_{n+j}u], \quad |\partial u|^{2} = \sum_{j=1}^{n} \partial_{j}u\overline{\partial_{j}u} = \frac{1}{4}|Du|^{2}.$$
$$\partial_{j\overline{j}}u = \frac{1}{4}[D_{jj}u + D_{n+jn+j}u].$$

In this paper, we establish global C^2 estimate of the Neumann problem of special Lagrangian equations with supercritical phase and obtain the existence theorem as follows:

Theorem 1.1. Suppose $\Omega \subset \mathbb{C}^n$ is a C^4 strictly pseudoconvex domain and $\varphi \in C^3(\partial\Omega)$. Let $\Theta(z) \in C^2(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$. Moreover, if the domain Ω satisfies a geometric condition

$$2\kappa_{\min} + \varepsilon > 0, \tag{1.3}$$

where κ_{\min} is the smallest principal curvature of $\partial\Omega$, then there exists a unique solution $u \in C^{3,\alpha}(\overline{\Omega})$ of the Neumann problem of special Lagrangian equation (1.2).

As Li mentioned in his paper [19], because the Neumann boundary condition is not invariant under the holomorphic changes of variables, the strictly pesudoconvex domain may not be enough and we need the extra curvature condition of the domain.

Furthermore, we can obtain the existence theorem of the classical Neumann problem of complex special Lagrangian equation as below.

Theorem 1.2. Suppose $\Omega \subset \mathbb{C}^n$ is a C^4 strictly convex domain and ν is outer unit normal vector of $\partial\Omega$. Let $\varphi \in C^3(\partial\Omega)$ and $\Theta(z) \in C^2(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$. Then there exists a unique constant β such that the Neumann problem of special Lagrangian equation

$$\begin{cases} \arctan \partial \bar{\partial} u = \Theta(z) & in \ \Omega, \\ D_{\nu} u = \beta + \varphi(z) & on \ \partial \Omega, \end{cases}$$
(1.4)

has admissible solutions $u \in C^{3,\alpha}(\overline{\Omega})$, which are unique up to a constant.

The rest of the paper is organized as follows. In Section 2, we collect some properties of the special Lagrangian equation and establish the C^0 estimate for the Neumann problem of special Lagrangian equation. The C^1 and C^2 estimates are established in Section 3, Section 4, respectively. At last, we prove Theorem 1.1 and Theorem 1.2 in Section 5.

2 Some properties and C⁰ estimate

In this section, we give some properties of the special Lagrangian equation with supercritical phase and establish the C^0 estimate.

2.1 Some properties

Property 2.1. Suppose $\Omega \subset \mathbb{C}^n$ is a domain and $\Theta(z) \in C^0(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$. Let $u \in C^2(\Omega)$ be a solution of special Lagrangian equation

$$\arctan \partial \bar{\partial} u = \Theta(z) \quad \text{in } \Omega.$$
 (2.1)

We assume $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n)$ are the eigenvalues of the Hessian matrix $\partial \overline{\partial} u$ with $\lambda_1 \ge \lambda_2 \dots \ge \lambda_n$, then we have some properties:

$$\lambda_1 \ge \cdots \ge \lambda_{n-1} > 0, \tag{2.2a}$$

$$|\lambda_n| \le \lambda_{n-1}, \tag{2.2b}$$

$$\sum_{i=1}^{n} \lambda_i > 0, \qquad (2.2c)$$

$$|\lambda_n| < C_0, \tag{2.2d}$$

where

$$C_0 = \max\left\{ \tan\left(\frac{(n-1)\pi}{2} - \min_{\overline{\Omega}}\Theta\right), \tan\left(\frac{1}{n}\max_{\overline{\Omega}}\Theta\right) \right\}$$

Proof. For any $i = 1, 2, \dots, n$, we know $\arctan \lambda_i \in (-\frac{\pi}{2}, \frac{\pi}{2})$. Then we can get

$$\arctan \lambda_{n-1} + \arctan \lambda_n = \Theta - \arctan \lambda_1 - \arctan \lambda_2 \cdots - \arctan \lambda_{n-2}$$
$$\geq \Theta - \frac{(n-2)\pi}{2} > 0.$$

So $\lambda_{n-1} + \lambda_n > 0$, which implies (2.2a), (2.2b) and (2.2c) hold. Moreover,

$$\arctan \lambda_n = \Theta - \arctan \lambda_1 - \arctan \lambda_2 - \dots - \arctan \lambda_{n-1} > \min_{\overline{\Omega}} \Theta - \frac{(n-1)\pi}{2}$$

and

$$\arctan \lambda_n < \frac{\arctan \lambda_1 + \arctan \lambda_2 + \dots + \arctan \lambda_n}{n} \leq \frac{1}{n} \max_{\overline{\Omega}} \Theta,$$

so we can get

$$|\lambda_n| < \max\left\{ \tan\left(\frac{(n-1)\pi}{2} - \min_{\overline{\Omega}}\Theta\right), \tan\left(\frac{1}{n}\max_{\overline{\Omega}}\Theta\right) \right\}.$$

Thus, we complete the proof.

Property 2.2. Suppose $\Omega \subset \mathbb{C}^n$ is a domain and $\Theta(z) \in C^2(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$. Let $u \in C^4(\Omega)$ be a solution of complex special Lagrangian equation (2.1). Then for any $\xi \in \mathbb{S}^{2n-1}$, we have

$$\sum_{ij=1}^{n} F^{i\bar{j}} D_{\xi\xi} \partial_{i\bar{j}} u \ge D_{\xi\xi} \Theta - A |D_{\xi} \Theta|^{2} \quad \text{in} \quad \Omega,$$
(2.3)

where

$$F^{i\bar{j}} = \frac{\partial \arctan \partial \bar{\partial} u}{\partial u_{i\bar{j}}}$$
 and $A = \frac{2}{\tan\left(\min_{\overline{\Omega}} \Theta - \frac{(n-2)\pi}{2}\right)}$.

Proof. For any $z \in \Omega$, we can assume $\partial \overline{\partial} u$ is diagonal with $\lambda_i = u_{i\overline{i}}$, since (2.3) is invariant under rotating the coordinates. Then we have

$$F^{i\bar{j}} =: \frac{\partial \arctan \partial \bar{\partial} u}{\partial u_{i\bar{j}}} = \begin{cases} \frac{1}{1+\lambda_i^2}, & \text{if } i=j, \\ 0, & \text{if } i\neq j, \end{cases}$$

and

$$F^{i\bar{j},k\bar{l}} =: \frac{\partial^2 \arctan \partial \bar{\partial} u}{\partial u_{i\bar{j}} \partial u_{k\bar{l}}} = \begin{cases} -\frac{2\lambda_i}{(1+\lambda_i^2)^2}, & \text{if } i=j=k=l, \\ -\frac{\lambda_i+\lambda_j}{(1+\lambda_i^2)(1+\lambda_j^2)}, & \text{if } i=l, j=k, i\neq j, \\ 0, & \text{otherwise.} \end{cases}$$

From the complex special Lagrangian equation (2.1), we know

$$\sum_{ij=1}^{n} F^{i\bar{j}} D_{\xi} \partial_{i\bar{j}} u = D_{\xi} \Theta$$

and

$$\sum_{ij=1}^{n} F^{i\bar{j}} D_{\xi\xi} \partial_{i\bar{j}} u = D_{\xi\xi} \Theta - \sum_{ijkl=1}^{n} F^{i\bar{j},k\bar{l}} D_{\xi} \partial_{i\bar{j}} u D_{\xi} \partial_{k\bar{l}} u$$
$$= D_{\xi\xi} \Theta - \sum_{i=1}^{n} F^{i\bar{i},i\bar{i}} (D_{\xi} \partial_{i\bar{i}} u)^2 - \sum_{i\neq j} F^{i\bar{j},j\bar{i}} |D_{\xi} \partial_{i\bar{j}} u|^2$$
$$\geq D_{\xi\xi} \Theta - \sum_{i=1}^{n} F^{i\bar{i},i\bar{i}} (D_{\xi} \partial_{i\bar{i}} u)^2.$$
(2.4)

From the concavity lemma (Lemma 2.2 in [8]), we know

$$-\sum_{i=1}^{n} F^{i\overline{i},i\overline{i}} (D_{\xi}\partial_{i\overline{i}}u)^{2} \ge -\frac{2}{\tan\left(\min_{\overline{\Omega}}\Theta - \frac{(n-2)\pi}{2}\right)} \left(\sum_{i=1}^{n} F^{i\overline{i}} D_{\xi}\partial_{i\overline{i}}u\right)^{2}$$
$$= -\frac{2}{\tan\left(\min_{\overline{\Omega}}\Theta - \frac{(n-2)\pi}{2}\right)} |D_{\xi}\Theta|^{2}. \tag{2.5}$$

Hence (2.3) holds.

2.2 C^0 estimate

The C^0 estimate is easy. For completeness, we produce a proof here following the idea of Lions-Trudinger-Urbas [23] and Ma-Qiu [24].

Theorem 2.3. Suppose $\Omega \subset \mathbb{C}^n$ is a \mathbb{C}^1 bounded domain and $\varphi \in \mathbb{C}^0(\partial\Omega)$. Let $\Theta(z) \in \mathbb{C}^0(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$ and $u \in \mathbb{C}^2(\Omega) \cap \mathbb{C}^1(\overline{\Omega})$ be the solution of complex special Lagrangian equation (1.2), then we have

$$-M_0 \le u(z) \le \frac{1}{\varepsilon} \max_{\partial \Omega} |\varphi| \quad in \quad \Omega,$$
(2.6)

where

$$M_0 = \frac{1}{\varepsilon} \max_{\partial \Omega} |\varphi| + \frac{2B}{\varepsilon} diam(\Omega) + B diam(\Omega)^2 \quad and \quad B = \tan\left(\frac{1}{n} \max_{\overline{\Omega}} \Theta\right) < +\infty.$$

Proof. From (2.2c), we know *u* is subharmonic. So the maximum of *u* is attained at a boundary point $z_0 \in \partial \Omega$. Then we can get

$$0 \le D_{\nu} u(z_0) = -\varepsilon u(z_0) + \varphi(z_0). \tag{2.7}$$

Hence

$$\max_{\overline{\Omega}} u = u(z_0) \le \frac{\varphi(z_0)}{\varepsilon} \le \frac{1}{\varepsilon} \max_{\partial \Omega} |\varphi|.$$
(2.8)

Without loss of generality, we assume $0 \in \Omega$ and denote

$$B = \tan\left(\frac{1}{n}\max_{\overline{\Omega}}\Theta\right) < +\infty.$$

Then we have

$$\arctan \partial \bar{\partial} u = \Theta \le \max_{\overline{\Omega}} \Theta = \arctan \partial \bar{\partial} (B|z|^2).$$
(2.9)

By the comparison principle, we know $u - B|z|^2$ attains its minimum at a boundary point $z_1 \in \partial \Omega$. Then

$$0 \ge D_{\nu}(u - B|z|^{2})|_{z=z_{1}} = D_{\nu}u(z_{1}) - BD_{\nu}(|z|^{2})|_{z=z_{1}}$$

= $-\varepsilon u(z_{1}) + \varphi(z_{1}) - 2B \cdot t \cdot \nu|_{z=z_{1}}$
 $\ge -\varepsilon u(z_{1}) - \max_{\partial \Omega} |\varphi| - 2B \operatorname{diam}(\Omega).$ (2.10)

Hence

$$\min_{\overline{\Omega}} u \ge \min_{\overline{\Omega}} (u - B|z|^2) = u(z_1) - B|z_1|^2$$

$$\ge -\frac{1}{\varepsilon} \max_{\partial\Omega} |\varphi| - \frac{2B}{\varepsilon} \operatorname{diam}(\Omega) - B \operatorname{diam}(\Omega)^2.$$
(2.11)

Thus, we complete the proof.

In this section, we prove the global gradient estimate by following the idea of Li [19].

Theorem 3.1. Suppose $\Omega \subset \mathbb{C}^n$ is a \mathbb{C}^3 bounded domain satisfying (1.3) and $\varphi \in \mathbb{C}^2(\partial\Omega)$. Let $\Theta(z) \in \mathbb{C}^1(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$ and $u \in \mathbb{C}^3(\Omega) \cap \mathbb{C}^2(\overline{\Omega})$ be a solution of complex special Lagrangian equation (1.2), then we have

$$\sup_{\overline{\Omega}} |Du| \le M_1, \tag{3.1}$$

where M_1 depends on n, Ω , $\kappa_{\min} + \varepsilon$, $|u|_{C^0}$, $\max_{\overline{\Omega}} \Theta$, $\min_{\overline{\Omega}} \Theta$ and $|\varphi|_{C^2}$.

Proof. In order to prove (3.1), it suffices to prove

$$D_{\xi}u(z) \le M_1, \quad \forall (z,\xi) \in \overline{\Omega} \times \mathbb{S}^{2n-1}.$$
 (3.2)

For any $(z,\xi) \in \overline{\Omega} \times \mathbb{S}^{2n-1}$, denote

$$W(z,\xi) = D_{\xi}u(z) - \langle v,\xi \rangle (-\varepsilon u + \varphi(z)) + K_0 u^2 + K_1 |z|^2,$$
(3.3)

where K_0 and K_1 are large constants to be determined later, and ν is a $C^2(\overline{\Omega})$ extension of the outer unit normal vector field on $\partial\Omega$. We still use $\varphi(z)$ to denote a C^2 extension of φ from $\partial\Omega$ to Ω . Assume W achieves its maximum at $(z_0, \xi_0) \in \overline{\Omega} \times S^{2n-1}$. It is easy to know $D_{\xi_0}u(z_0) > 0$. We claim $z_0 \in \partial\Omega$. Otherwise, if $z_0 \in \Omega$, we rotate the coordinates such that $\{\partial_{i\bar{j}}u(z_0)\}$ is diagonal with $\lambda_i = u_{i\bar{i}}$ and $\lambda_1 \geq \lambda_2 \geq \cdots \geq \lambda_n$. Then we have

$$F^{i\bar{j}} =: \frac{\partial \arctan \partial \bar{\partial} u}{\partial u_{i\bar{j}}} = \begin{cases} \frac{1}{1+\lambda_i^2}, & \text{if } i=j, \\ 0, & \text{if } i\neq j. \end{cases}$$

Hence we can get from Property 2.1

$$F^{1\bar{1}} \leq F^{2\bar{2}} \leq \cdots \leq F^{n\bar{n}},$$

$$F^{n\bar{n}} = \frac{1}{1 + \lambda_n^2} \geq c_0 > 0,$$

$$F^{i\bar{i}} u_{i\bar{i}} = \frac{\lambda_i}{1 + \lambda_i^2} \in \left(-\frac{1}{2}, \frac{1}{2}\right),$$

where

$$c_0 = \frac{1}{1 + \max\{\tan\left(\frac{(n-1)\pi}{2} - \min_{\overline{\Omega}}\Theta\right), \tan\left(\frac{1}{n}\max_{\overline{\Omega}}\Theta\right)\}^2}.$$

For fixed $\xi = \xi_0$, $W(z, \xi_0)$ achieves its maximum at the same point $z_0 \in \Omega$ and we can easily get that at z_0 ,

$$0 \geq F^{i\bar{j}} \partial_{i\bar{j}} W = F^{i\bar{i}} [\partial_{i\bar{i}} D_{\xi_0} u - \langle v, \xi_0 \rangle_{i\bar{i}} (-\varepsilon u + \varphi) - \langle v, \xi_0 \rangle (-\varepsilon u_{i\bar{i}} + \varphi_{i\bar{i}}) - \langle v, \xi_0 \rangle_i (-\varepsilon u_{\bar{i}} + \varphi_{\bar{i}}) - \langle v, \xi_0 \rangle_{\bar{i}} (-\varepsilon u_i + \varphi_i) + 2K_0 u_i u_{\bar{i}} + 2K_0 u_{i\bar{i}} + K_1] \geq D_{\xi_0} \Theta + (2K_0 - C_1) \sum_{i=1}^n F^{i\bar{i}} u_i u_{\bar{i}} + [2K_0 u + \varepsilon \langle v, \xi_0 \rangle] \sum_{i=1}^n F^{i\bar{i}} u_{i\bar{i}} + (K_1 - C_1) \sum_{i=1}^n F^{i\bar{i}},$$
(3.4)

where C_1 is a positive constant depending only on n, ε , $|u|_{C^0}$, $|\varphi|_{C^2}$ and $|v|_{C^2}$.

Take $K_0 = \frac{C_1}{2}$ and $K_1 = 2C_1 + \frac{2|D\Theta| + n[2K_0|u| + \varepsilon]}{c_0}$. Using

$$\sum_{i=1}^{n} F^{i\bar{i}} u_{i\bar{i}} \in \left(-\frac{n}{2}, \frac{n}{2}\right), \qquad \sum_{i=1}^{n} F^{i\bar{i}} > F^{n\bar{n}} \ge c_{0},$$

we can get

$$0 \ge F^{ij} \partial_{i\bar{j}} W$$

$$\ge -|D_{\xi_0} \Theta| - \frac{n}{2} [2K_0|u| + \varepsilon] + (2K_0 - C_1) \sum_{i=1}^n F^{i\bar{i}} u_i u_{\bar{i}} + (K_1 - C_1) \sum_{i=1}^n F^{i\bar{i}}$$

>0. (3.5)

This is a contradiction. So $z_0 \in \partial \Omega$. Then we continue our proof in the following three cases.

(a) If ξ_0 is normal at $z_0 \in \partial \Omega$, then

$$W(z_0,\xi_0) = K_0 u^2 + K_1 |z_0|^2 \le C_2.$$

Then we can easily get (3.2).

(b) If ξ_0 is non-tangential at $z_0 \in \partial \Omega$, then we can write $\xi_0 = \alpha \tau + \beta \nu$, where $\tau \in \mathbb{S}^{2n-1}$ is tangential at z_0 , that is $\langle \tau, \nu \rangle = 0$, $\alpha = \langle \xi_0, \tau \rangle > 0$, $\beta = \langle \xi_0, \nu \rangle < 1$, and $\alpha^2 + \beta^2 = 1$. Then we have

$$W(z_0,\xi_0) = \beta D_{\tau} u + K_0 u^2 + K_1 |z_0|^2$$

$$\leq \beta W(z_0,\xi_0) + (1-\beta)(K_0 u^2 + K_1 |z_0|^2), \qquad (3.6)$$

so

$$W(z_0,\xi_0) \leq K_0 u^2 + K_1 |z_0|^2 \leq C_3.$$

Then we can easily get (3.2).

(c) If ξ_0 is tangential at $z_0 \in \partial \Omega$, we may assume that the outer normal direction of Ω at z_0 is $(0, \dots, 0, 1)$. By a rotation, we assume that $\xi_0 = (1, \dots, 0) = e_1$. Then we have

$$0 \leq D_{\nu}W(z_{0},\xi_{0}) = D_{\nu}D_{1}u - D_{\nu}\langle\nu,\xi_{0}\rangle(-\varepsilon u + \varphi) + 2K_{0}u \cdot D_{\nu}u + K_{1}D_{\nu}|z|^{2}$$

$$\leq D_{\nu}D_{1}u + C_{4}$$

$$= D_{1}D_{\nu}u - D_{1}\nu_{k}D_{k}u + C_{4}.$$
(3.7)

By the boundary condition, we know

$$D_1 D_\nu u = D_1 (-\varepsilon u + \varphi) \le -\varepsilon W(z_0, \xi_0) + C_5.$$
 (3.8)

Following the argument of [19], we can get

$$-D_1 \nu_k D_k u \le -\kappa_{\min} W(z_0, \xi_0) + C_6. \tag{3.9}$$

From (1.3), it holds $\kappa_{\min} + \varepsilon > 0$. So

Remark 3.1. To prove Theorem 1.2, we need to consider the complex special Lagrangian equation (1.2) with $\varepsilon \to 0$. Under the assumptions of Theorem 1.2, that is, $\Omega \subset \mathbb{C}^n$ is a C^4 strictly convex domain, $\varphi \in C^3(\partial\Omega)$, $\Theta(z) \in C^2(\overline{\Omega})$ and $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$, and for any sufficiently small ε , we can obtain the following proof of Theorem 2.3

$$\sup_{\overline{\Omega}} \varepsilon |u^{\varepsilon}| \le \widetilde{M}_0, \tag{3.11}$$

for the solution u^{ε} of (1.2), where \widetilde{M}_0 depends on n, $diam(\Omega)$, $\max_{\overline{\Omega}} \Theta$, and $|\varphi|_{C^0}$. Moreover, we can choose test function

$$W(z,\xi) = D_{\xi}u^{\varepsilon}(z) - \langle \nu, \xi \rangle (-\varepsilon u^{\varepsilon} + \varphi(z)) + K_0(\varepsilon u^{\varepsilon})^2 + K_1 |z|^2,$$

and following the proof of Theorem 3.1, we can choose K_0 and K_1 independent of ε , and obtain the global gradient estimate

$$\sup_{\overline{\Omega}} |Du^{\varepsilon}| \le \widetilde{M}_1, \tag{3.12}$$

where \widetilde{M}_1 depends on n, Ω , $\max_{\overline{\Omega}} \Theta$, $\min_{\overline{\Omega}} \Theta$, $|\Theta|_{C^1}$ and $|\varphi|_{C^2}$, and is independent of ε . It is easy to know

$$\sup_{\overline{\Omega}} \left| u^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} u^{\varepsilon} \right| \leq \widetilde{M}_{1}.$$

4 Global second derivatives estimate

We now come to the a priori estimate of global second derivatives. Firstly, we prove the estimate of double normal second derivatives on boundary, and then we complete the proof of global second derivatives estimate.

4.1 Estimate of double normal second derivatives on boundary

Theorem 4.1. Suppose $\Omega \subset \mathbb{C}^n$ is a C^4 strictly pseudoconvex domain and $\varphi \in C^3(\partial\Omega)$. Let $\Theta(z) \in C^2(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$ and $u \in C^4(\Omega) \cap C^3(\overline{\Omega})$ be the solution of complex special Lagrangian equation (1.2), then we have

$$\max_{\partial O} |D_{\nu\nu}u| \le \overline{M_2},\tag{4.1}$$

where $\overline{M_2}$ depends on n, Ω , $\max_{\overline{\Omega}} \Theta$, $|u|_{C^1}$, $\min_{\overline{\Omega}} \Theta$, $|\Theta|_{C^2}$ and $|\varphi|_{C^3}$.

Proof. Since Ω is a C^4 strictly pseudoconvex domain, there is a strictly plurisubharmonic defining function $r \in C^4(\overline{\Omega})$ such that

$$|Dr| = 1 \qquad \text{on } \partial\Omega, \tag{4.2a}$$

$$\partial \partial r \ge k_0 I_n$$
 in Ω , (4.2b)

where k_0 is a positive constant depending only on Ω and I_n is the $n \times n$ identity matrix.

Let $z_0 \in \partial \Omega$ be an arbitrary point. By a shift and a rotation of the coordinates $\{z_1, \dots, z_n\}$, we can assume that $z_0 = 0$, $\partial_{z_i} r(0) = 0$ for i < n, and $D_{t_n} r(0) = -1$, $D_{t_{2n}} r(0) = 0$. In $\overline{B}(0,\delta) \cap \overline{\Omega}$, a sufficiently small neighborhood of z_0 , we can get by the Taylor expansion of r up to second order

$$r(z) = -Re\left(z_n - \sum_{ij=1}^n a_{ij} z_i z_j\right) + \sum_{ij=1}^n b_{i\bar{j}} z_i \overline{z_j} + \mathcal{O}(|z|^3),$$
(4.3)

where $\{b_{i\bar{j}}\} = \partial \bar{\partial} r(0)$ is positive definite. We now introduce new coordinates $z' = \psi(z)$ of the form

$$z'_i = z_i$$
 for $i < n$, $z'_n = z_n - \sum_{ij=1}^n a_{ij} z_i z_j$. (4.4)

In $\psi(\overline{B}(0,\delta) \cap \overline{\Omega})$, we have

$$r(z)|_{z=\psi^{-1}(z')} = -Rez'_n + \sum_{ij=1}^n b_{i\bar{j}} z'_i \overline{z'_j} + \mathcal{O}(|z'|^3),$$
(4.5)

Denote

$$r_{0}(z') = -Rez'_{n} + \sum_{ij=1}^{n} b_{ij}z'_{i}z'_{j},$$

$$B_{j}(z') = \left(\sum_{i=1}^{n} [a_{ij} + a_{ji}]z_{i}\right)\Big|_{z=\psi^{-1}(z')}, \quad j = 1, \dots, n,$$

$$A_{j}(z') = B_{j}(1 - B_{n})^{-1}\frac{\partial r_{0}(z')}{\partial \overline{z'_{n}}}, \quad j = 1, \dots, n-1.$$

It is easy to know $|B_j| = O(|z'|)$ for $j = 1, \dots, n$, and A_j is holomorphic in $z' \in \psi(\overline{B}(0, \delta) \cap \overline{\Omega})$. Following the calculations in [19], we know the Neumann boundary condition in z' coordinates

$$4Re\left(\langle\partial_{z'}u,\partial_{z'}r_0\rangle - \sum_{j=1}^{n-1}A_j\partial_{z'_j}u\right) = \phi(z',u) + \mathcal{O}(|z'|^3),\tag{4.6}$$

where

$$\phi(z',u) = |1 - B_n(z')|^{-2} (-\varepsilon u + \varphi(z))|_{z = \psi^{-1}(z')}$$

Following the idea of [19], we choose the auxiliary function

$$h(z') = 4Re\left[\langle \partial_{z'}u, \partial_{z'}r_0 \rangle - \sum_{j=1}^{n-1} A_j \partial_{z'_j}u\right] - \phi(z', u) + Kr(z)|_{z=\psi^{-1}(z')} - K_1Re(z'_n), \quad (4.7)$$

where $K_1 > 0$ is sufficiently large so that

$$h < 0$$
 on $\psi(\partial(B(0,\delta)) - \partial\Omega)$,

and

$$h = -K_1 Re(z'_n) + \mathcal{O}(|z'|^2) \le 0 \quad \text{on } \psi(\partial(B(0,\delta)) \cap \partial\Omega).$$

Let

$$F^{i\bar{j}} = \frac{\partial \arctan \partial_z \overline{\partial_z} u}{\partial u_{z_i \overline{z_j}}}, \quad G^{i\bar{j}} = \frac{\partial \arctan \partial_z \overline{\partial_z} u}{\partial u_{z_i' \overline{z_j'}}}.$$

It is easy to know

$$G^{i\bar{j}} = F^{p\bar{q}} \left(\frac{\partial z'_i}{\partial z_p} \right) \overline{\left(\frac{\partial z'_j}{\partial z_q} \right)}.$$

For any $z' \in \psi(B(0,\delta) \cap \Omega)$, we can get

$$\begin{split} G^{i\bar{j}}\partial_{z_{i}'\bar{z}_{j}'}h =& 2G^{i\bar{j}}\partial_{z_{i}'\bar{z}_{j}'}\left(\partial_{z_{k}'}u\partial_{\overline{z_{k}'}}r_{0} + \partial_{\overline{z_{k}'}}u\partial_{z_{k}'}r_{0}\right) - 2G^{i\bar{j}}\partial_{z_{i}'\bar{z}_{j}'}\left(\sum_{k=1}^{n-1}A_{k}\partial_{z_{k}'}u + \overline{A_{k}}\partial_{\overline{z_{k}'}}u\right) \\ &-G^{i\bar{j}}\partial_{z_{i}'\bar{z}_{j}'}\phi + KG^{i\bar{j}}\partial_{z_{i}'\bar{z}_{j}'}r \\ =& 2G^{i\bar{j}}\left(\partial_{z_{k}'}u_{z_{i}'\bar{z}_{j}'}\partial_{\overline{z_{k}'}}r_{0} + \partial_{\overline{z_{k}'}}u_{z_{i}'\bar{z}_{j}'}\partial_{\overline{z_{k}'}}r_{0} + u_{z_{k}'\bar{z}_{j}'}\partial_{z_{i}'\bar{z}_{k}'}r_{0} + u_{\overline{z_{k}'}z_{i}'}\partial_{z_{k}'\bar{z}_{j}'}r_{0}\right) \\ &-2\sum_{k=1}^{n-1}G^{i\bar{j}}\left(A_{k}\partial_{z_{k}'}u_{z_{i}'\bar{z}_{j}'} + \overline{A_{k}}\partial_{\overline{z_{k}'}}u_{z_{i}'\bar{z}_{j}'} + \partial_{z_{i}'}A_{k}u_{z_{k}'\bar{z}_{j}'} + \overline{\partial_{z_{j}'}A_{k}}u_{z_{i}'\bar{z}_{k}'}\right) \\ &-G^{i\bar{j}}[|1 - B_{n}(z')|^{-2}\left(-\varepsilon u_{z_{i}'\bar{z}_{j}'} + \varphi_{z_{i}'\bar{z}_{j}'}\right) + \partial_{z_{i}'\bar{z}_{j}'}\left(|1 - B_{n}(z')|^{-2}\right)\left(-\varepsilon u + \varphi\right)] \\ &+KG^{i\bar{j}}\partial_{z_{i}'\bar{z}_{j}'}}r \end{split}$$

where $F^{p\bar{q}}u_{z'_k\overline{z_q}} = F^{p\bar{q}}u_{z_m\overline{z_q}}\frac{\partial z_m}{\partial z'_k}$ and $F^{p\bar{q}}u_{z_p\overline{z'_k}} = F^{p\bar{q}}u_{z_p\overline{z_m}}(\overline{\partial z_m})$ are bounded by rotating the coordinates $\{z_1, \dots, z_n\}$ such that $\partial_z\overline{\partial_z}u$ is diagonal. From (2.2d), we know

$$\sum_{p=1}^{n} F^{p\bar{p}} \ge c_0, \tag{4.9}$$

where

$$c_0 = \frac{1}{1 + \max\{\tan\left(\frac{(n-1)\pi}{2} - \min_{\overline{\Omega}}\Theta\right), \tan\left(\frac{1}{n}\max_{\overline{\Omega}}\Theta\right)\}^2}$$

Taking $K = \frac{C_7}{k_0c_0}$, we can have $G^{i\bar{j}}\partial_{z'_i\bar{z}'_j}h \ge 0$ in $\psi(B(0,\delta)\cap\Omega)$. By the maximum principle, we know h(z') achieves its maximum at z'=0. Hence $h(z')|_{z'=\psi(z)}$ achieves its maximum at $z_0=0$. Thus

$$0 \le D_{\nu} h(0) \le D_{\nu\nu} u(z_0) + C_8. \tag{4.10}$$

So we have $D_{\nu\nu}u(z_0) \ge -C_8$.

The same argument for

4.2 Estimate of global second derivatives

Theorem 4.2. Suppose $\Omega \subset \mathbb{C}^n$ is a \mathbb{C}^4 strictly pseudoconvex domain satisfying (1.3) and $\varphi \in C^3(\partial\Omega)$. Let $\Theta(z) \in C^2(\overline{\Omega})$ with $\frac{(n-2)\pi}{2} < \Theta(z) < \frac{n\pi}{2}$ in $\overline{\Omega}$ and $u \in C^4(\Omega) \cap C^3(\overline{\Omega})$ be a solution

of special Lagrangian equation (1.2), then we have

$$\sup_{\overline{\Omega}} |D^2 u| \le M_2, \tag{4.13}$$

where M_2 depends on n, Ω , $2\kappa_{min} + \varepsilon$, $\max_{\overline{\Omega}} \Theta$, $\min_{\overline{\Omega}} \Theta$, $|u|_{C^1}$, $|\Theta|_{C^2}$ and $|\varphi|_{C^3}$.

Proof. From (2.2c), we know

$$\Delta u = 4 \sum_{i=1}^{n} u_{i\bar{i}} = 4(\lambda_1 + \dots + \lambda_n) > 0$$

By the argument in Li's [19], we know that we only need to prove that

$$0 \leq D_{\nu}Q(z_{0},\zeta_{0}) = D_{\nu}D_{\zeta_{0}\zeta_{0}}u - D_{\nu}a_{l}D_{l}u - a_{l}D_{\nu}D_{l}u - D_{\nu}b + 2D_{k}uD_{\nu}D_{k}u + K_{1}D_{\nu}|z|^{2}$$

$$\leq D_{\nu}D_{\zeta_{0}\zeta_{0}}u + [2D_{k}u - a_{k}]D_{\nu}D_{k}u + C_{11}.$$
(4.21)

By the boundary condition, we know

$$D_{\nu}D_{\zeta_{0}\zeta_{0}}u = D_{\zeta_{0}\zeta_{0}}D_{\nu}u - (D_{\zeta_{0}\zeta_{0}}v^{k})D_{k}u - 2(D_{\zeta_{0}}v^{k})D_{\zeta_{0}}D_{k}u$$

$$= D_{\zeta_{0}\zeta_{0}}(-\varepsilon u + \varphi) - (D_{\zeta_{0}\zeta_{0}}v^{k})D_{k}u - 2(D_{\zeta_{0}}v^{k})D_{\zeta_{0}}D_{k}u$$

$$\leq -\varepsilon Q(z_{0},\zeta_{0}) + C_{12} - 2(D_{\zeta_{0}}v^{k})D_{\zeta_{0}}D_{k}u.$$
(4.22)

Following the argument of [19], we can get

$$|D_{\nu}D_{k}u| \leq C_{13},$$

-2($D_{\zeta_{0}}v^{k}$) $D_{\zeta_{0}}D_{k}u \leq -2\kappa_{\min}Q(z_{0},\zeta_{0})+C_{14}.$

From (1.3), it holds $2\kappa_{\min} + \varepsilon > 0$. So

$$Q(z_0,\zeta_0) \le \frac{C_{11} + C_{12} + (2|Du| + |a_k|)C_{13} + C_{14}}{2\kappa_{\min} + \varepsilon}.$$
(4.23)

Then we can easily get (4.14).

Remark 4.1. As the discussions in Remark 3.1, to prove Theorem 1.2, we need to consider the complex special Lagrangian equation (1.2) with $\varepsilon \rightarrow 0$. Under the assumptions of Theorem 1.2, and for any sufficiently small ε , we can obtain the following proof of Theorem 4.1 and Theorem 4.2,

$$\sup_{\overline{\Omega}} |D^2 u^{\varepsilon}| = \sup_{\overline{\Omega}} \left| D^2 \left(u^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} u^{\varepsilon} \right) \right| \le \widetilde{M}_2, \tag{4.24}$$

where \widetilde{M}_2 depends on n, Ω , $\max_{\overline{\Omega}} \Theta$, $\min_{\overline{\Omega}} \Theta$, $|\Theta|_{C^2}$ and $|\varphi|_{C^3}$, and is independent of ε .

5 Existence of the boundary problems

In this section we complete the proofs of the Theorem 1.1 and Theorem 1.2.

5.1 **Proof of Theorem 1.1**

For the Neumann problem of complex special Lagrangian equation (1.2), we have established the C^0 , C^1 and C^2 estimates in Section 2, Section 3, Section 4, respectively. By the global C^2 priori estimate, the special Lagrangian equation (1.2) is uniformly elliptic in $\overline{\Omega}$.

From the concavity Lemma (Lemma 2.2 in [8]), we know $-e^{-A \arctan \partial \delta u}$ is concave with respect to $\partial \overline{\partial} u$, where *A* is defined in Property 2.2. Following the discussions in [22], we can get the global Hölder estimates of second derivative,

$$|u|_{C^{2,\alpha}(\overline{\Omega})} \le C,\tag{5.1}$$

where *C* and α depend on *n*, Ω , $\max_{\overline{\Omega}}\Theta$, $\min_{\overline{\Omega}}\Theta$, $|\Theta|_{C^2}$ and $|\varphi|_{C^3}$. From (5.1), one also obtains $C^{3,\alpha}(\overline{\Omega})$ estimates by differentiating Eq. (1.2) and applies the Schauder theory for linear uniformly elliptic equations.

Applying the method of continuity (see [21]), the existence of the classical solution holds. By the standard regularity theory of uniformly elliptic partial differential equations, we can obtain the higher regularity.

5.2 Proof of Theorem 1.2

By a similar proof of Theorem 1.1, we know there exists a unique solution $u^{\varepsilon} \in C^{3,\alpha}(\overline{\Omega})$ to (1.2) for any small $\varepsilon > 0$. Let $v^{\varepsilon} = u^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} u^{\varepsilon}$, and it is easy to know that v^{ε} satisfies

$$\begin{cases} \arctan \partial \bar{\partial} v^{\varepsilon} = \Theta(z) & \text{in } \Omega, \\ D_{\nu}(v^{\varepsilon}) = -\varepsilon v^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} \varepsilon u^{\varepsilon} + \varphi(z) & \text{on } \partial \Omega. \end{cases}$$
(5.2)

By the global gradient estimate (3.12), it is easy to know $\varepsilon \sup |Du^{\varepsilon}| \to 0$. Hence there is a constant β and a function $v \in C^2(\overline{\Omega})$, such that

$$-\varepsilon u^{\varepsilon} \rightarrow eta, \quad -\varepsilon v^{\varepsilon} \rightarrow 0, \quad -\frac{1}{|\Omega|} \int_{\Omega} \varepsilon u^{\varepsilon} \rightarrow eta, \quad v^{\varepsilon} \rightarrow v,$$

uniformly in $C^2(\overline{\Omega})$ as $\varepsilon \to 0$. It is easy to verify that v is a solution of

$$\begin{cases} \arctan \partial \bar{\partial} v = \Theta(z) & \text{in } \Omega, \\ D_v v = \beta + \varphi(z) & \text{on } \partial \Omega. \end{cases}$$
(5.3)

If there is another function $v_1 \in C^2(\overline{\Omega})$ and another constant β_1 such that

$$\begin{cases} \arctan \partial \bar{\partial} v_1 = \Theta(z) & \text{in } \Omega, \\ D_{\nu}(v_1) = \beta_1 + \varphi(z) & \text{on } \partial \Omega. \end{cases}$$
(5.4)

Applying the maximum principle and Hopf Lemma, we can know $\beta = \beta_1$ and $v - v_1$ is a constant. By the standard regularity theory of uniformly elliptic partial differential equations, we can obtain the higher regularity.
